Section 3 – External Auditor’s Report and Certificate 2024/25

In respect of **Rangeworthy Parish Council**

1 Respective responsibilities of the auditor and the authority

Our responsibility as auditors to complete a **limited assurance review** is set out by the National Audit Office (NAO). A limited assurance review is **not a full statutory audit**, it does not constitute an audit carried out in accordance with International Standards on Auditing (UK & Ireland) and hence it **does not** provide the same level of assurance that such an audit would. The UK Government has determined that a lower level of assurance than that provided by a full statutory audit is appropriate for those local public bodies with the lowest levels of spending.

Under a limited assurance review, the auditor is responsible for reviewing Sections 1 and 2 of the Annual Governance and Accountability Return in accordance with NAO Auditor Guidance Note 02 (AGN 02 as issued by the NAO on behalf of the Comptroller and Auditor General. In the prior year, the smaller authority was exempt from review, therefore we have not reviewed any evidence to support the prior year comparatives on the AGAR.

The AGAR was not accurately completed before submission for review:

- Assertion 9 of the Annual Governance Statement (AGS) was incorrectly answered Yes and subsequently amended to N/a.
- Question 11a was answered Yes in the Accounting Statements (AS) and subsequently amended to No.
- Question 11b was answered Yes in the Accounting Statements and subsequently amended to N/a.
- Box 8 Cash & short term investments in the Accounting Statements was incorrect and amended to 71,254.

The form was also re-signed but the original submission did comply with the Accounts and Audit Regulations 2015. The AS was certified by the RFO on 27 May 2025 and the AGAR was approved on 03 June 2025.
